### **SWABS**

Swabs 1 & 3 for **CEM** must be sent chilled to: VLA, Rouham Hill, Bury St. Edmunds, Suffolk, IP33 2RX.

**\*\*Swab 3 is a mandatory requirement for EU export and there MUST be exactly 7 days between Swab 1 and swab 3\*\***

Swab 2 for **CEM, Klebsiella & Pseudomonas** must be sent chilled to: Animal Health Trust, Diagnostic Services, Lanwades Park, Kentford, Newmarket, Suffolk, CB8 7UU

- (b) EHV I & EHV IV, Vesicular stomatitis, Equine exanthema, Equine Coital exanthema, Salmonella abortus equi within the past 3 months.
- (c) Strangles within the past 30 days.
- (d) Ringworm within the past 30 days.
